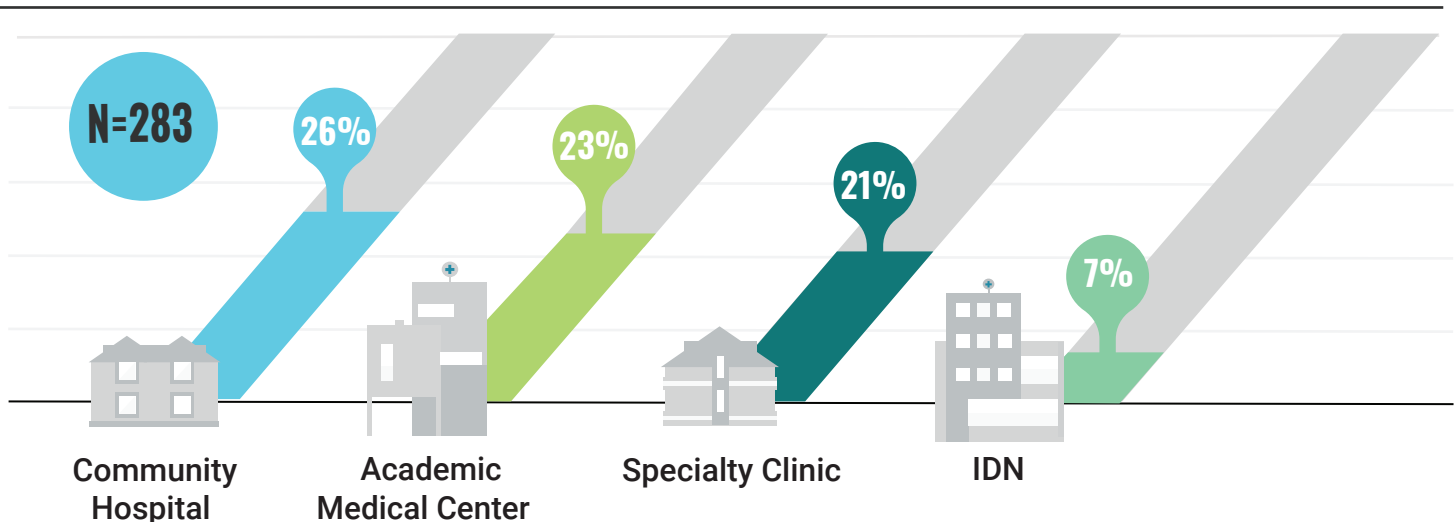

Introduction

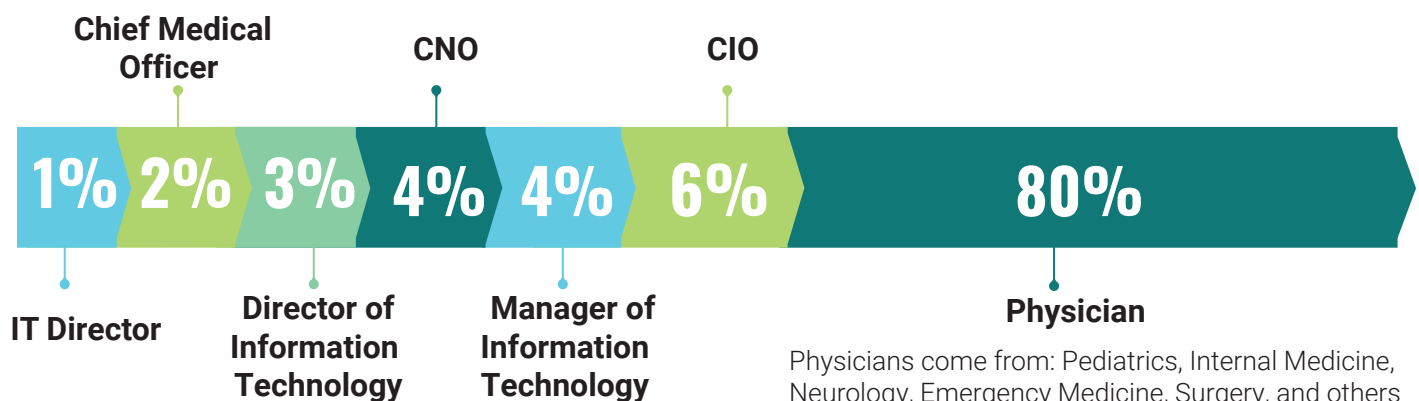

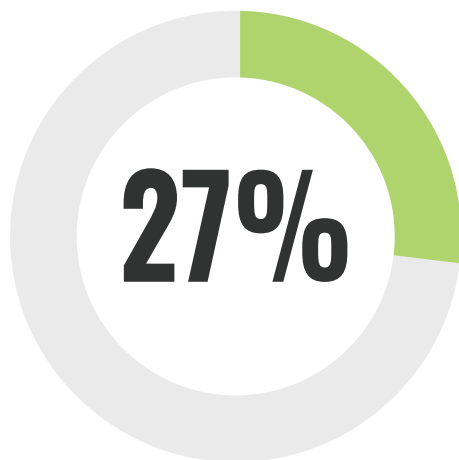

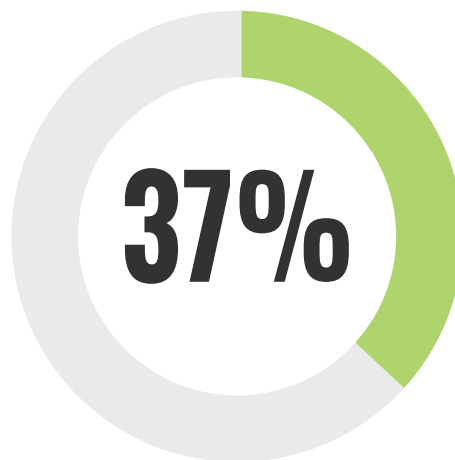

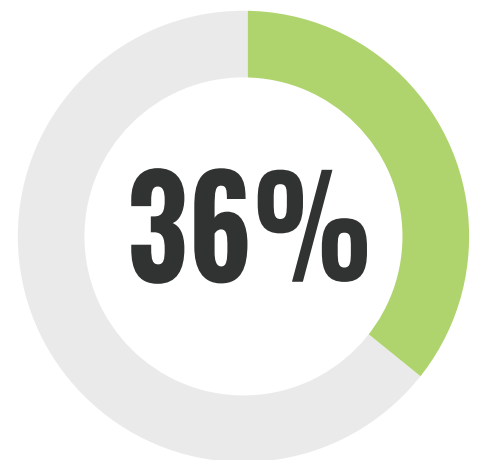

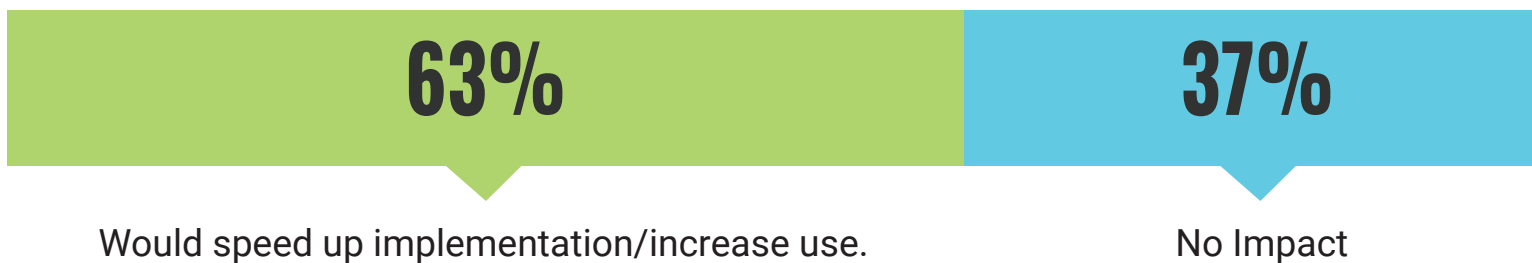

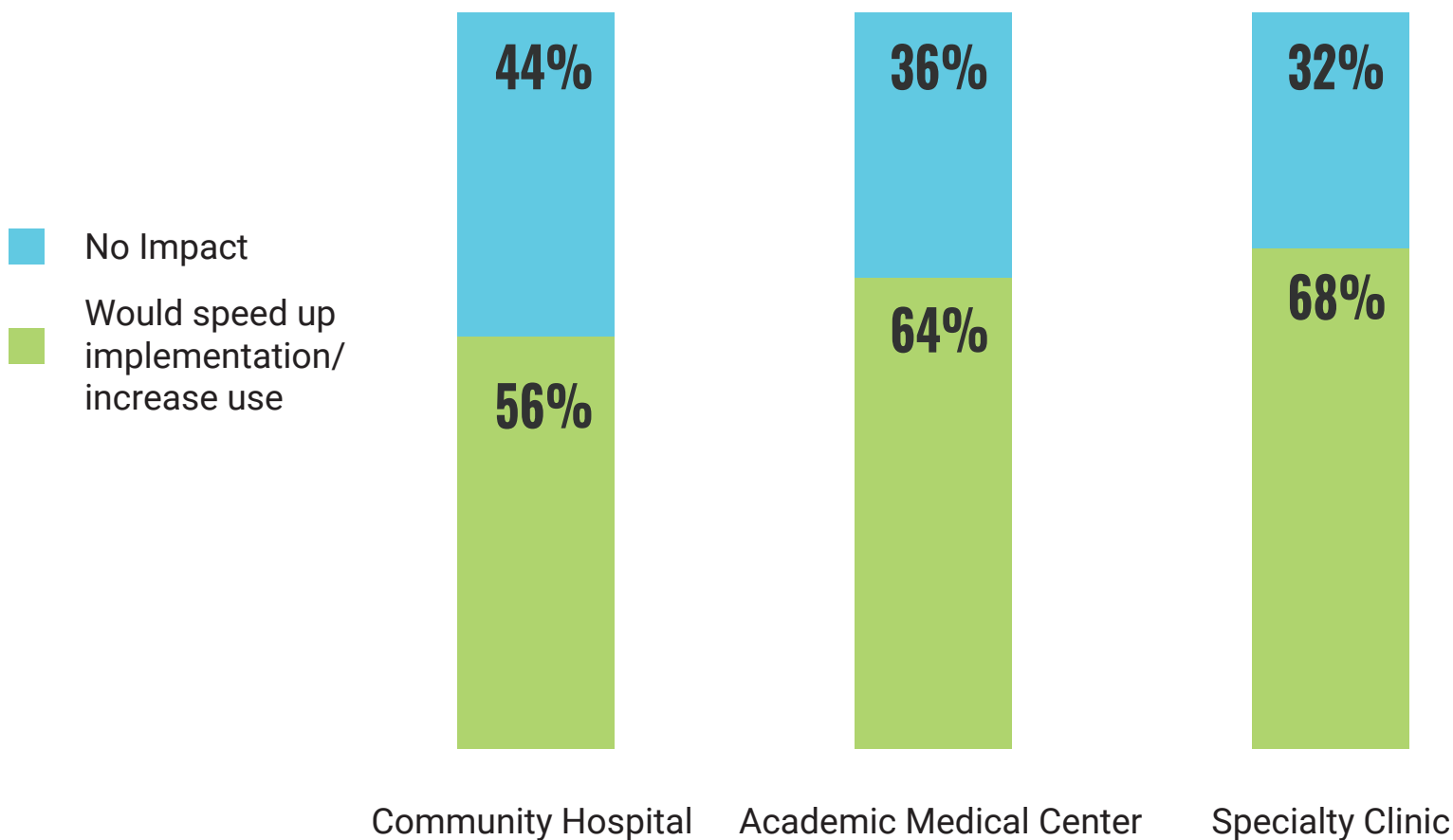

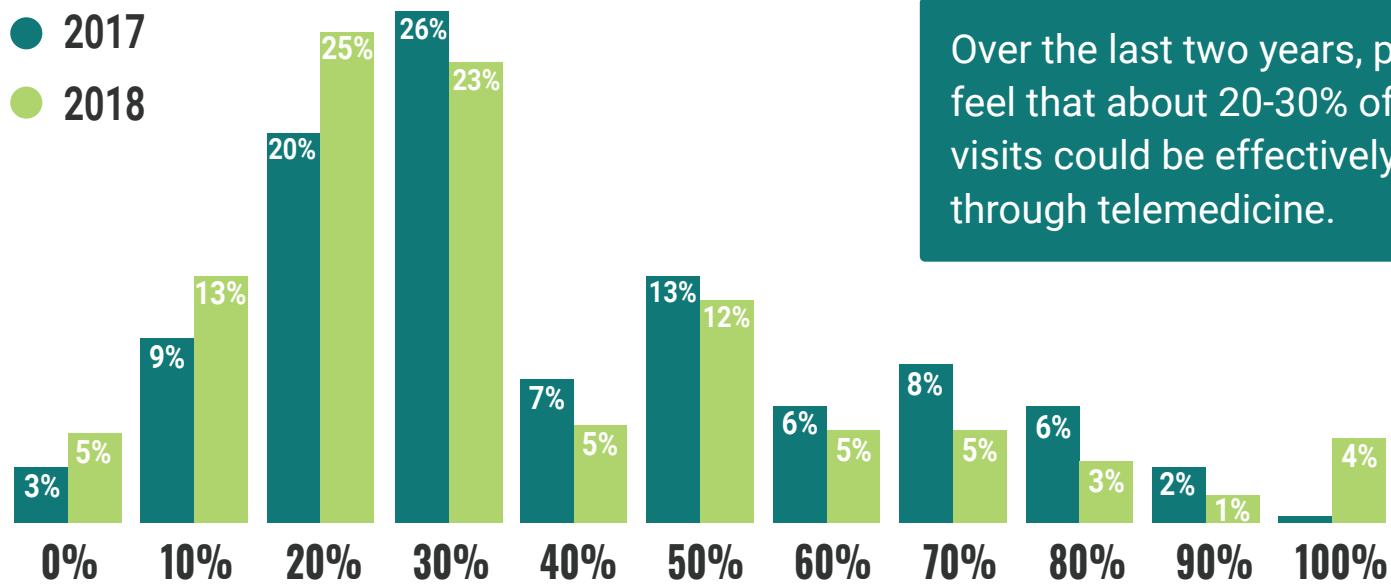
Effect of Increased Telemedicine Reimbursement on Adoption Timelines



Effect of Increased Reimbursement By Organization Type

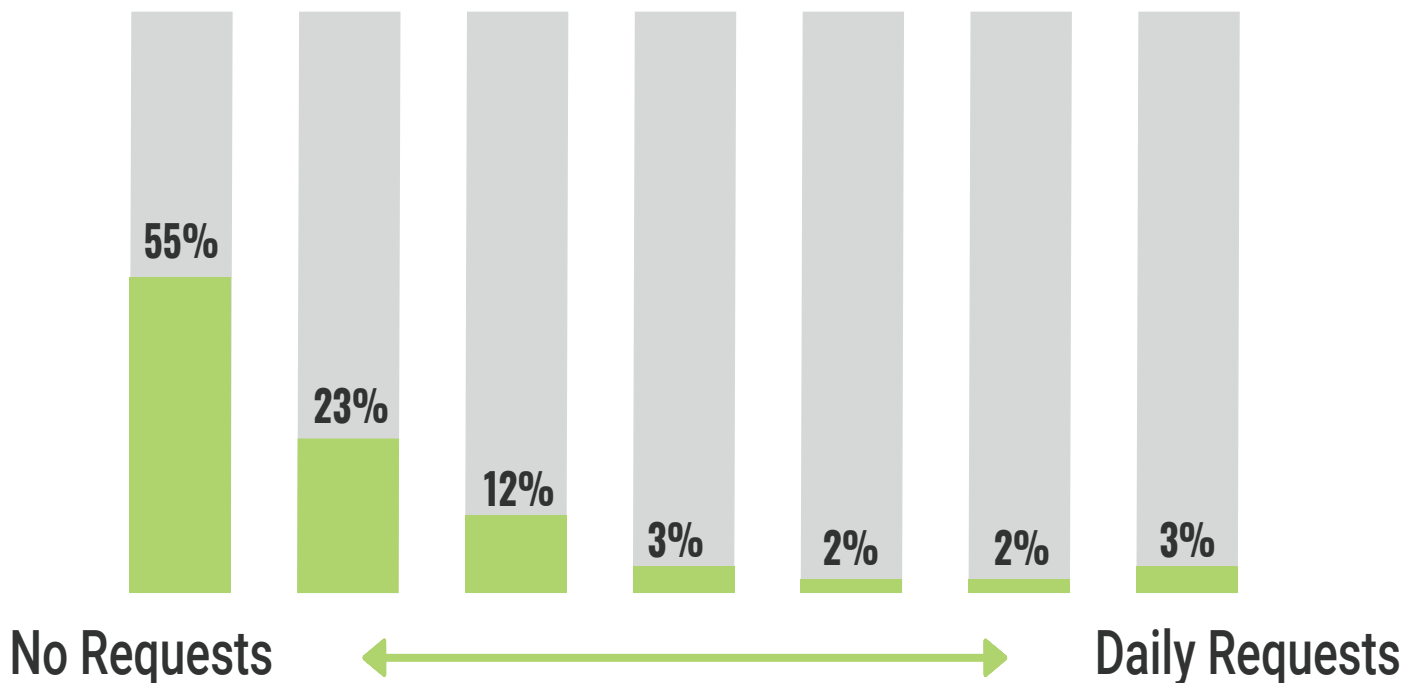


Percent of Patient Visits That Could be Effectively Handled Through Telemedicine

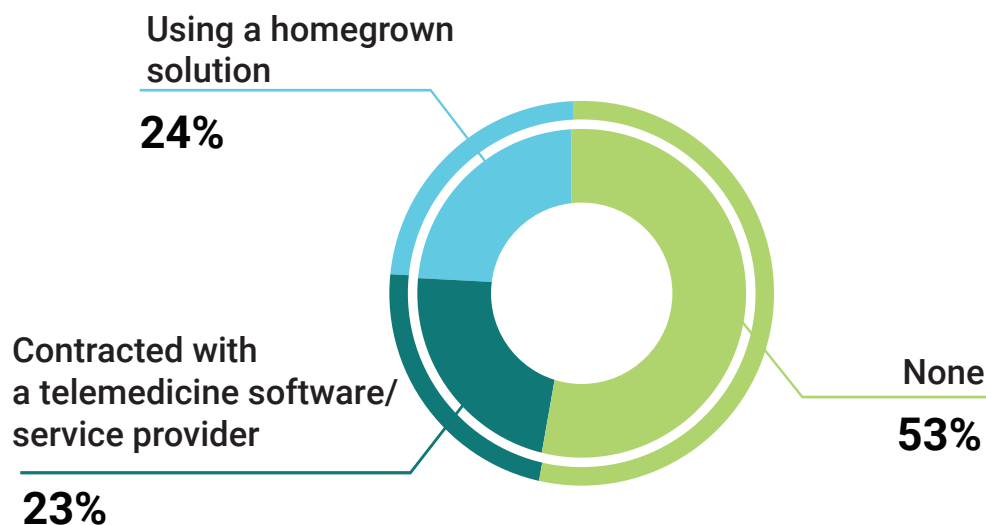


Over the last two years, providers feel that about 20-30% of patient visits could be effectively handled through telemedicine.

How Often Patients Request Telemedicine Visits



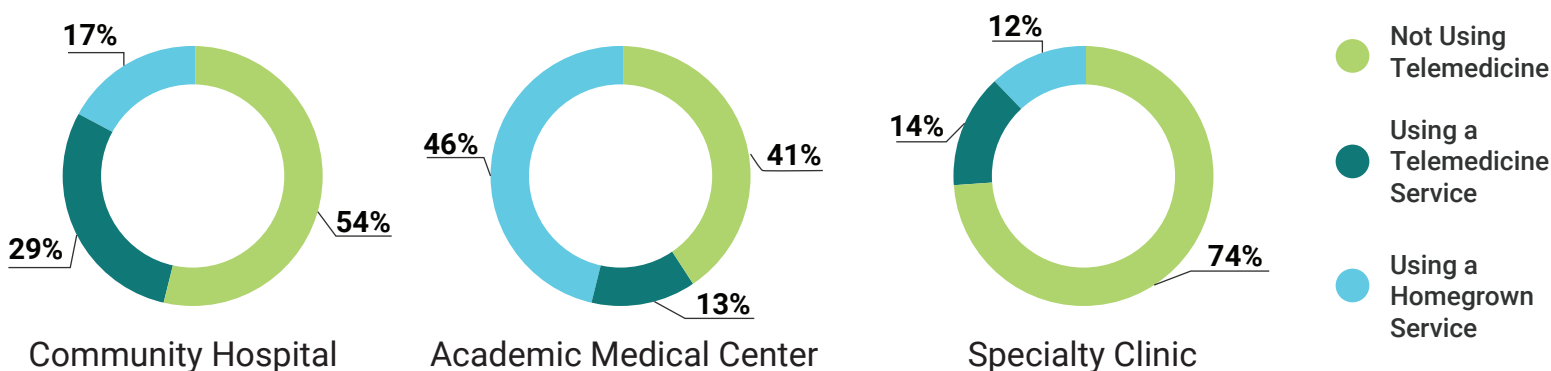

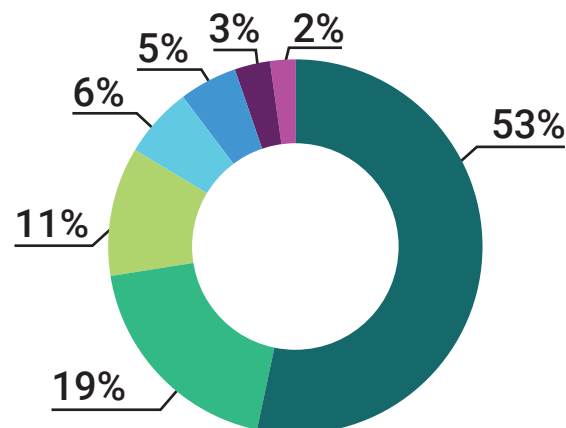

Adoption Rates by Org Type

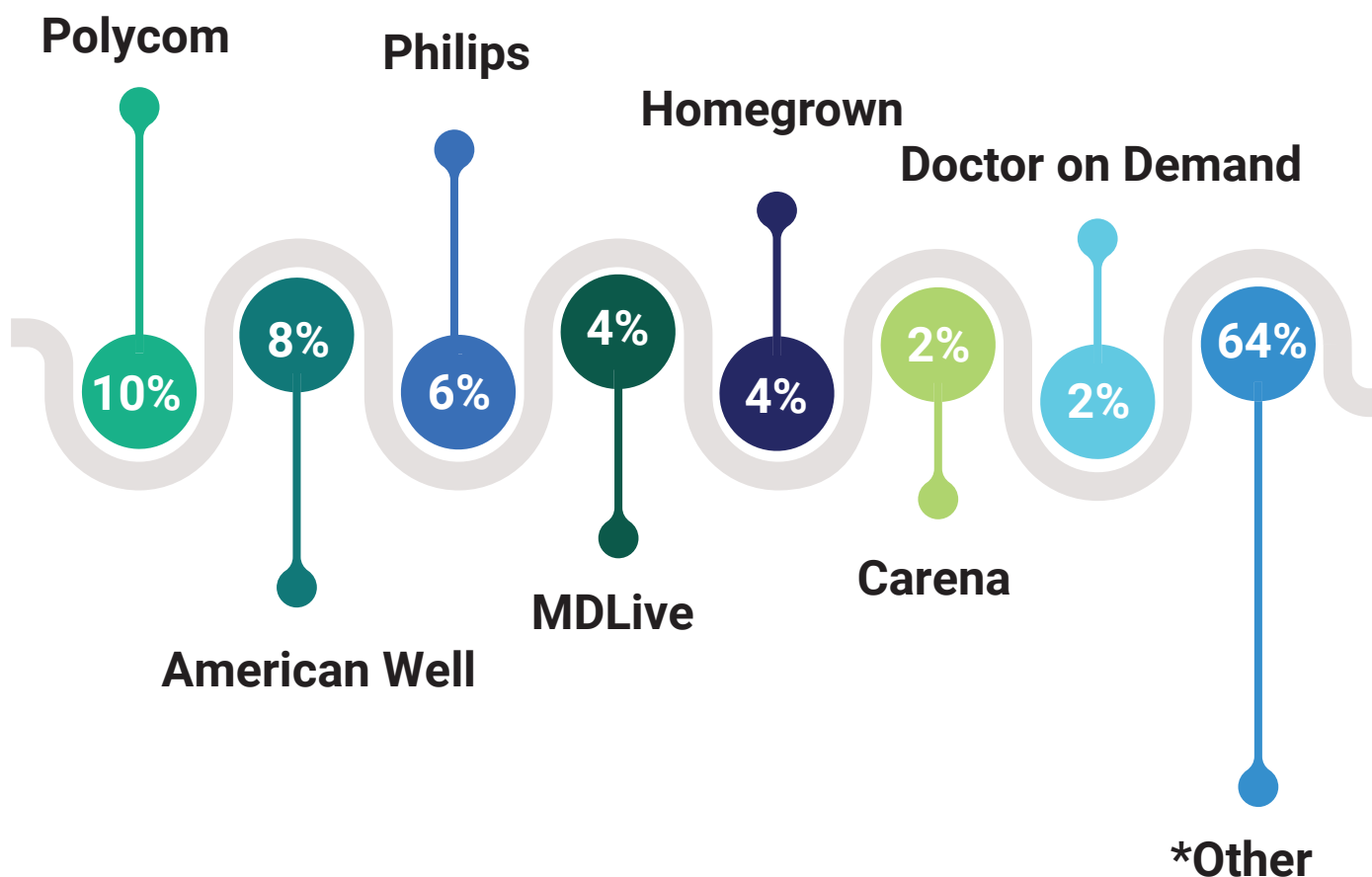


Telemedicine Adoption Plans

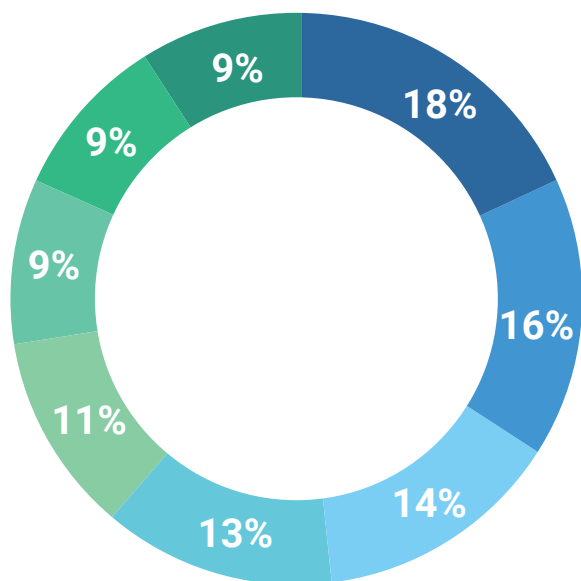

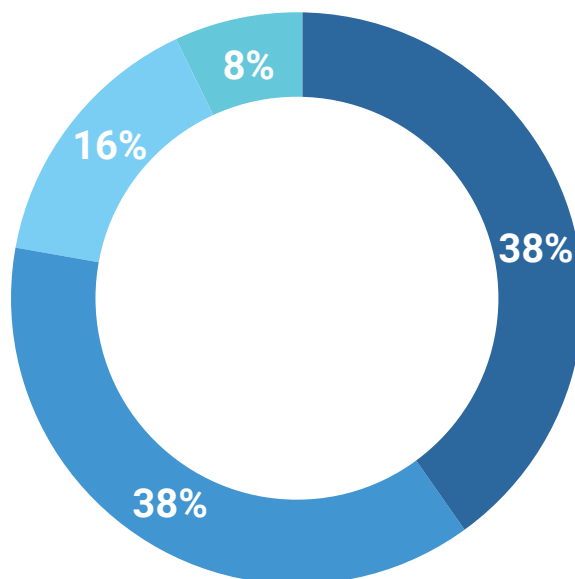
Greatest Benefits From Telemedicine
